EU Reg.to 2016/679: Art. 15, 16, 17, 18, 19, 20, 21, 22 - Rights of the Data Subject

1. The interested party has the right to obtain confirmation of the existence or otherwise of personal data concerning him/her, even if not yet recorded, their communication in intelligible form and the possibility of making a complaint to the Supervisory Authority.

2. The interested party has the right to obtain the indication:

- a. the origin of the personal data;
- b. the purposes and methods of the processing;
- c. the logic applied in the case of processing carried out with the aid of electronic tools;
- d. the identification details of the Data Controller, the Data Processors and the Designated Representative pursuant to Article 5, paragraph 2;
